

# **IPRT SUBMISSION TO THE PROBATION SERVICE STRATEGY 2021-2023 PUBLIC CONSULTATION SURVEY** 2<sup>nd</sup> March 2021

## **Pillar 1: Enhancing Community Safety**

# 1. Please provide detail on any relevant actions for this pillar / priority area:

- (a.) Provide effective and tailored community sanctions and early release programmes nationwide that meet the needs of individuals and particular cohorts (e.g. women). This action is important in the context of the Covid-19 pandemic, particularly in regards how the absence of face-to-face contact has impacted service-users.
- (b.) Continue to improve sentence management for people in prison and work with families to support positive post-release outcomes. Rehabilitation and reintegration must be at the core of the Probation Service's strategy and are essential to achieving the community safety objective.
- (c.) Liaise with relevant bodies to ensure that offenders have access to suitable accommodation, supports and services.
- (d.) Increase engagement with media to enhance public understanding about the Probation Service, focussing on 'what works' and dispelling proposals that are not supported by evidence e.g. the disclosure of information on persons who sexually offend to the wider public.

#### 2. Please provide detail on any relevant indicators of success for this pillar / priority area:

- (a.) Offenders have access to suitable community sanctions and early release programmes nationwide. Tangible (e.g., recidivism rates) and 'soft' outcomes for offenders engaged in community sanctions programmes are tracked and published in the Probation Service's Annual Report. A review of probation practice (both learnings and challenges) during the Covid-19 pandemic are published and considered.
- (b.) The number and quality of probation interventions with people in prison are tracked, assessed, and published in the Probation Service's Annual Report.
- (c.) Joint protocols between the Probation Service and bodies such as Local Housing Authorities exist, are publicly available to access and are implemented.
- (d.) The Probation Service has increased engagement with the media. The general public have a greater understanding of its work and the importance of evidence-based interventions.

#### 1. Please provide detail on any relevant actions for this pillar / priority area:

(a.) Establish a Steering Committee focused on Community Sanctions. This committee should comprise of key stakeholders including members of the Judiciary, the Irish Prison Service, the Department of Justice, and community-based organisations. This committee should have a programme of work including, for example: reviewing the impact of the Covid-19 pandemic

- on various areas of work such as parole; enhancing the delivery of community sanctions for women; and expanding the eligibility of early release programmes such as Community Support Schemes and Community Return.
- (b.) Provide training and updates to the Courts and other stakeholders on the work of the Probation Service e.g. awareness-raising on the importance of pre-sentence reports and completion rates of Community Service Orders and Probation Orders.
- (c.) Establish a council comprised of service users to advise and inform the work of the Probation Service.

## 2. Please provide detail on any relevant indicators of success for this pillar / priority area:

- (a.) There is an increased use of Community Service Orders and a marked reduction in short-term prison sentences imposed at District Court level. There is no evidence of a 'net widening' of community sanctions. Community sanctions are being consistently applied throughout District Courts in Ireland and short prison sentences (i.e. sentences less than 12 months) are abolished. Data is being collected and published which shows that District Court judges generally accept recommendations made by the Probation Service in pre-sentence reports.
- (b.) Members of the judiciary and other criminal justice stakeholders nationwide have a greater understanding of probation options as an alternative to prison.
- (c.) A Council has been established and the views of individuals on probation are heard in relevant forums to support and inform evidence-based policy-making.

(a.) Data is published that shows that underrepresented and particularly vulnerable cohorts (some of which are mentioned above) have equity of access to probation sanctions. There are tailored programmes available across the country to meet the needs of specific cohorts.

- (b.) A target percentage of persons with convictions histories are employed by the Probation Service.
- (c.) All probation staff have received training in cultural competency, gender-based violence and the Public Sector Equality and Human Rights Duty.

Champion and raise awareness that the Probation Service pro-actively hires persons with convictions histories. This would support a cultural change of public attitudes towards the employment of persons with convictions.
